 - Make suer to check out a record of deleted course as well as to keep the final result.
- O The withdrawal-approval-result will be notified through mobile APP 「부산 대학교 스마트캠퍼스 앱(PNU Smartcampus APP」.(The notice will be sent when 'Dept. of Educational Affairs' approves the withdrawal.) So please download the APP if you wish to receive the notice. (Students must log-in after downloading APP to receive the notification.)

- Subject Students : Undergradutes (Includes students from other schools)
 - * Course withdrawal is unavailable for students in the certain department under flunk system. (Department of Medicine)

The Number of Courses students can withdraw : within 2 courses

The remaining credits registered after the withdrawal(W) must be \underline{at} lease 12 credits or more (Students in 7^{th} semester or more must be $\underline{taking 1}$ credit or more).

- It is not allowed for students to drop the course whose remaining credit becomes less than 12 credits after withdrawal(W).(Students who are in 7th semester: must register more than 1 credit)

5 Notes

- A. When a students applies for 'course withdrawal', the student will be excluded from the candidate of 'Credit Transfer(학점이월제)' for the next semester.
 - * (Credit Transfer : 학점이월제) When a student register less credits than registerable credits, and some credits are remaining from the previous semester, the student can transfer <u>up to 2 credits</u> to the next semester, and use this extra credits for course registration(only 1 time).
 - ※ Students with outstanding academic performance(성적우수자) can get additional 3 credits in the next semester even if some courses are withdrawn.(under the condition that earned credits are more than 18, and the total GPA is over 3.8)
- B. Withdrawn courses will not be listed on the academic transcript and are excluded from grade evaluation, credit acquisition, and GPA calculation.
- C. Adding course registration after the course withdrawal period or taking back course withdrawal is not available, the final application record and result must be confirmed and kept by oneself (by printing out or screen capturing), so that there is no

- disadvantage cause by any omission or error.
- D. For the students who applied for payments per credit, the difference due to the course withdrawal will be refunded by the end of April. * Inquiries: Accounting Dept. 051-510-1051
